

Senior Special Investigator

OVERVIEW

Perform duties in support of the resolution of "Cold Case" homicide investigations by leading complex case reviews, conducting specialized investigative actions, and collaborating with agencies. Work alongside law enforcement as a non-certified professional staff to assess and resolve cold cases, while mentoring junior investigators.

DUTIES & RESPONSIBILITIES

Duties may vary based on assignment.

- Lead and review cold case homicide investigations with partially tested evidence for outsourced lab testing and/or new laboratory analysis for potential leads and any other investigative action as necessary.
- Re-examine old cases, utilizing modern investigative techniques and prioritizing solvability based on newly discovered evidence or methods.
- Prepare and disseminate cold case review information to the Cold Case Volunteer Working Group; organize and facilitate meetings to discuss cases, assess potential leads, and determine solvability.
- Collaborate with federal, state, and private agencies that may contribute to solving cold cases
- Respond to citizen inquiries regarding cold cases, providing information and guidance as appropriate.
- Locate witnesses, and identify and collect relevant documents, information, and evidence related to cold cases.
- Conduct interviews of cold case victims and/or witnesses.
- Compose extensive reports, memos, and other correspondence related to cold cases.
- Assist homicide detectives in obtaining probable cause to support legal demands related to cold cases.
- Serve criminal subpoenas, legal processes, and documents as required.
- Prepare case files for presentation to the prosecutor's office.
- Mentor and/or supervise junior investigators, fostering their professional growth and development.
- Testify in court as required.
- Perform other related duties as required.

- Skill in the use of cellular analysis in criminal investigations.
- Skill in the application of interviewing and interrogation techniques.
- Skill in evidence gathering techniques and procedures.
- Skill in techniques used for submitting forensic evidence for laboratory analysis.
- Skill in making presentations to groups.
- Ability to use innovative approaches to conducting criminal investigations.
- Ability to analyze statements and evidence to develop logical conclusions for further investigation.
- Ability to communicate effectively both orally and in writing.
- Ability to prepare and maintain records, reports, and other cold case documentation.
- Ability to establish and maintain liaison with civilian volunteers supporting the homicide cold case initiative.
- Ability to use a computer and related software.
- Ability to deal with confidential information.
- Ability to be compassionate when interviewing or corresponding with victims and/or witnesses.

WORKING CONDITIONS

- Work within an office environment within a law enforcement agency, courthouse/court complex, and/or detention facility.
- Work outdoors in a subtropical climate in potential adverse weather conditions.
- View objectionable images and/or disturbing situations.
- Interact with the public regarding information of a sensitive/emotional nature.
- Work can be physically demanding, stressful, and dangerous.
- Remain in a stationary position for extended periods of time at a scene, event, or workstation.
- May engage in heavy physical exertion (e.g., lifting, carrying, pushing and/or pulling objects and materials up to 50 pounds).
- Drive a Sheriff's Office-issued vehicle (e.g., car, full-size van, full-size pickup truck) to interview victims and/or witnesses.
- Shift work: May work day or night shifts and non-standard hours/days including weekends and holidays.
- In the event of an emergency or disaster, may be required to respond promptly to duties and responsibilities as assigned by management chain, Division/District Commander, or the Sheriff (or their designee). Such assignments may be for before, during or after the emergency/disaster.

MINIMUM EDUCATION & EXPERIENCE

- A high school diploma or possession of a GED certificate.
- Seven years of law enforcement experience, with at least five years as a latent investigator handling complex investigations.
- Three years of service with the Hillsborough County Sheriff's Office.
- Completion of specialized training in cold case investigations, forensic interviewing, or investigative technologies

OR

- An associate degree with a major in forensic science, criminology, criminal justice, criminal law, or a related field from an accredited institution of higher education.
- Six years of law enforcement experience, with at least 5 years as a latent investigator

- handling complex investigations.
- Three years of service with the Hillsborough County Sheriff's Office.
- Completion of specialized training in cold case investigations, forensic interviewing, or investigative technologies

OR

- A bachelor's degree with a major in forensic science, criminology, criminal justice, criminal law, or a related field from an accredited institution of higher education.
- Four years of law enforcement experience, with at least five years as a latent investigator handling complex investigations.
- Three years of service with the Hillsborough County Sheriff's Office.
- Completion of specialized training in cold case investigations, forensic interviewing, or investigative technologies.

ADDITIONAL JOB REQUIREMENTS

- Attendance at the specified Sheriff's Office work location is required.
- Depending on assignment, employees may be required to possess a valid Florida Driver License at time of employment. Driving history will be thoroughly reviewed and may be grounds for disqualification.
- No visible tattoos on face, head, and neck. Tattoos determined to take away from the
 professional appearance of the Sheriff's Office must be covered with an appropriate white,
 black, or neutral covering.
- No illegal drug sale within lifetime.
- No illegal drug use within the past 36 months. No marijuana use within the last 12 months.
- No felony convictions within lifetime.
- No misdemeanor convictions involving perjury, false statement, or domestic violence within lifetime.
- No dishonorable discharge from any branch of the United States Armed Forces, the United States Coast Guard, National Guard, or Reserve Forces.
- Successful completion of a background investigation including criminal, reference, employment, and neighborhood checks; polygraph; medical evaluation; and drug screening.
- Live within Hillsborough County or within Citrus, Hardee, Hernando, Lake, Manatee, Pasco, Pinellas, Polk, Sarasota, or Sumter County as long as the residence is located within the 60mile parameter of Falkenburg Road Jail at the time of appointment/employment (certified only).
