SUBJECT: Amendment No. 1 to RFP 13-18 Sheriff's Operations Center Chiller Upgrade

MESSAGE: Please note and acknowledge the following changes or additions to be included in the referenced section(s) of RFP 13-18:

1. Special Provisions, (Part B)(1) – Replace 1. in its entirety, as follows:

1. IN GENERAL

The purpose of this Request for Proposal (RFP) is to describe the requirements of the Hillsborough County Sheriff's Office (HCSO) to secure the services of a qualified Contractor to upgrade the existing air conditioning equipment servicing the main section of the Malcolm E. Beard Sheriff's Operations Center (MEBSOC). The existing equipment is comprised of one (1) cooling tower and two (2) water cooled chillers which provide a total of 140 tons of cooling capacity to the facility.

2. Special Provisions, (Part B)(2) – Replace 2. in its entirety, as follows:

2. SCOPE OF WORK

The Scope of Work will be to upgrade existing equipment by providing and installing a new cooling tower and two (2) water cooled chillers with water pumps or an air cooled unit to include any necessary modification to piping, electrical connections and controls. The Contractor will be responsible for all engineering and permitting. All equipment is to be current production high efficiency equipment. Installation of materials and products will be in accordance with manufacturers' recommendations and specifications.

Any reference to the "Work" throughout this RFP is defined to be inclusive of the Scope of Work and any related performance detailed herein. For further details, refer to Technical Specifications (Part C).

3. Technical Specifications, (Part C)(2) – Add paragraph (e.) as follows:

e. Air Cooled Unit Option

The Contractor may provide an alternate Proposal Response for an Air Cooled Unit. If selecting this option, it is critical to ensure that the footprint of the building will accommodate the new equipment.

4. Page 30 will be replaced in its entirety, see attached.

Please note that this document hereby becomes a part of RFP No. 13-18 and without this document, the Proposal is considered incomplete.
