Please provide an optional deduction for not furnishing the bollards.

Please provide a pricing option for welding all piping. The pricing option for welding shall be considered as a separate line item on the Proposal Response.

Please include the standard warranty pricing, information and warranty period in your proposal.

Please provide optional pricing to warranty the parts and labor for five (5) years, separate from the total pricing.

Additionally, please provide an electronic copy of the cost proposal in excel format that includes all costs associated with the elements described above. The method of delivery for the electronic cost proposal is USB flash drive. **Do not email any part of your bid.** 

The undersigned certifies that any exceptions to the RFP specifications are noted in the PROPOSAL RESPONSE (PART D). All specifications not noted thereon are as requested. The undersigned also understands that any exceptions presented after the award may be cause for cancelation of award.
