<u>BID OVERVIEW</u>: The purpose of this Invitation to Bid (Bid) is for HCSO to obtain quotes for the purchase of Daniel Defense carbine rifles and accessories.

Bids will be received until the time and date shown and will be read aloud immediately thereafter at the "Place" indicated. A video recording of the Bid opening will then be posted to the Hillsborough County Sheriff's Office (HCSO) website https://TeamHCSO.com/Purchasing.

As per Part B Special Provisions paragraph 13 CONTRACT PERIOD: The Contract shall be effective for one (1) year from the date of award. By written mutual consent between the HCSO and the Vendor, the Contract may be extended on an annual basis for up to three (3) additional one (1) year periods.

The initial purchase quantities of 68 Patrol Carbines and 13 SWAT Carbines are to address our current, immediate needs. This bid is expected to be used to replace approximately 550 Patrol Carbines and approximately 10 - 25 SWAT Carbines over the term of the contract.
