Section 2 Specifications and Scope of Work

The intent of this Term Contract (TC) is to obtain quotes and fixed pricing for the procurement of law enforcement uniform accessories to meet the operational needs of the Hillsborough County Sheriff's Office. The awarded supplier shall furnish and deliver law enforcement related uniform accessories on an as-needed basis.

Manufacturer names and model numbers listed below are provided **for reference purposes only** to describe the requested items and establish minimum specifications. Equivalent products meeting or exceeding these specifications may be offered, unless otherwise stated in the solicitation.

The items to be purchased include the following:

- **Hat Protector** – Stratton F-42, Large & Extra Large, Hat sizes 6 $\frac{3}{4}$ to 7 $\frac{5}{8}$ in regular and long oval.
- **Raincoat** – PIP Falcon 353-1048, ANSI-compliant, Type R, Class 3, 48" raincoat, sizes SM–4XL
- **Traffic Safety Vest** – Evershield DOR Mesh Safety Vest, model LUX-PSS-DOR, size XL
- **Traffic Safety Gloves** – Ranger Gloves model 307-09, size medium
- **Whistle** – HWC nickel-plated No. NPW-1 or gold-plated No. GPW-1
- **Inner Belt** – Dutyman model 1311 Garrison Belt, sizes 24"–60"
- **Clip-On Tie** – Samuel Broome model 900-BLK, sizes 15", 16", 18", 20", and 22"

The Awarded Supplier shall prominently display the solicitation number 2026-005 on all quotations, invoices, packing slips, and any other documentation related to this solicitation. This requirement facilitates accurate order tracking and payment processing. Non-compliance may lead to processing delays.

2.1 Required Samples

One (1) sample shall be required for each proposed item. Samples must be delivered to the location specified in Section 4.8, TC Sample Packing Label. All samples are due on or before the deadline identified in Section 4.8.

2.2 Contract Period and renewal.

The Contract shall be effective for three (3) years from the initial date of award. By written mutual consent between the HCSO and the Supplier, the Contract may be extended for up to two (2) additional two (2) year periods.

2.3 Evaluation of Goods

Certain items under this solicitation, particularly those issued as part of official uniforms, may be subject to award decisions based on the requesting division's discretion. In such cases, award determinations may consider factors such as quality, appearance, and suitability for the intended use, as defined by the division's standards and preferences. Different methods of evaluating items may be used; however, a justification for the award decision will be documented at a minimum. These items will not be awarded solely on price; instead, the division will evaluate and select products that best meet its operational needs.
